

CONNECTION FEES 2026

Developer/builder is to supply meter pit/vault, cast iron bonnet or 24 inch ring and cover, curb stop valve, curb stop box, meter setter, all copper and related fittings and labor per Crestview Engineering Standards.

Builders Note: Every water connection and every sewer connection requires two (2) fees.
 For water, one fee by Crestview and one fee by Denver Water.
 For sewer, one fee by Crestview and one fee by Metro Water Recovery.

***** Reimbursement Agreement *****

Any future development that is constructed between Federal Blvd. and Zuni Street and 68th ave. and 72nd ave. that connects to either of Crestview's water distribution system or sanitary sewer collection system is required to pay an additional reimbursement fee per the details below.

A Single family residential unit will be charged a reimbursement fee of \$2,871 above and beyond Crestview's connection fees.
 Multi-family developments will be charged a reimbursement fee of \$3,016 per unit above and beyond Crestview's connection fees.
 Commercial properties will be charged a reimbursement fee of \$2,871 per Single Family Residential Equivalent (SFRE) above and beyond Crestview's connection fees.

Calculations of total water charges will be performed after the final number of SFREs are provided.
